Notice & Instructions for Application Empanelment for the Ad-hoc Panel (History)

Applications are invited on the prescribed proforma for empanelment in the Adhoc Panel for the posts of Assistant Professor in History in the constituent Colleges of the University of Delhi for the academic session 2023-24.

Please read the following instructions and Eligibility conditions carefully before applying:

- 1. Applications are invited from all the candidates who fulfill the minimum eligibility requirements as laid down by the UGC Regulations 2018/University of Delhi rules/Departmental criterions. Candidates must submit their application both in soft copy as well as hard copy along with all the necessary self-attested documents mentioned in this notification and in the prescribed form.
- 2. All the aspirants, including those already having their names in the existing panels, require applying afresh. With the issuance of the new Adhoc Panel prepared on the basis of the applications received during April 2023, all the existing Adhoc Panels in history will automatically lapse. So, it is mandatory for every candidate to apply again for the purpose of rectification/correction in the existing data.
- 3. Please note Applications submitted only through the following google form by April 30th (5 PM) will be entertained.

- 5. In addition to filling the google form, posting the physical copy of the filled and signed application form with self-attested copies of relevant documents is also mandatory. For this, the candidates would be required to print the copy of filled form they will receive on their email and sign it. Application forms along with all annexures should be posted to the Office of the Department of History, 1st Floor, Social Science Building, University of Delhi, Delhi-110007. These should be only posted; not personally submitted. The hard copies must reach by May 4th 2023 until 4 pm. Late applications will not be considered.
- 6. Criteria for allotment of categories (as specified by University rules/Departmental criterion) will be as under:

- 7. ALL applicants must submit either a NET certificate or a NET exemption certificate from their RESPECTIVE Departments. Candidates, who have been awarded a Ph.D. Degree in History in accordance with the University Grants Commission (Minimum Standards and Procedure for award of PhD Degree) Regulations 2009, shall be exempted from the requirement of NET, subject to their production of an appropriate certificate in this respect. The FORM REQUIRED OF RESEARCH SCHOLARS IS APPENDED AS ANNEXURE. If your university provides a different, less comprehensive statement, please submit that form together with ALL the supporting qualifications required by the University of Delhi. This includes a copy of your degree, copies of your two published research papers (cover page/page showing full citation details only) and proof of two presentations in conferences/seminars.
- 8. Candidates registered for the Ph.D. prior to 11th July, 2009 are governed by the provisions of the then existing ordinances/Bye Laws/Regulations of the Institutions awarding the degree. Such PhD degree holders shall be exempted from the requirement of NET, subject to the production of an appropriate certificate indicating the following:
 - A. That the PhD Degree of the candidate was awarded in the regular mode.
 - B. That the two external examiners did the evaluation of the Ph.D. thesis.
 - C. That an open Ph.D. viva voce examination of the candidate was conducted.
 - D. That the candidate has published two research papers based on his/her Ph.D. work out of which at least one was in a refereed journal. If your certificate does not specifically acknowledge this, then please supply copies of the publications (cover page/page showing full citation details).
 - E. That the candidate had made at least two presentations in conferences/seminars based on his/her Ph.D. work. If the certificate does not specifically acknowledge this, then please supply proof of these presentations.
- 9. Candidates who have obtained their Ph.D. in the concerned subject from a foreign University that is among the top 500 in the World University Ranking according to QS, THE or the ARWU (see Gazette of India, July 18, 2018, p. 60 for details) have NET exemption.
- 10. If any condition changes because of the UGC and University of Delhi rules and regulations regarding the qualifications required for empanelment as Ad-hoc/Guest Assistant Professor in the Departments of History of the constituent Colleges of University of Delhi, a notification will be put up and subsequently the Adhoc panel will be revised accordingly. The revised panel, if any, will also be put up on the website. No individual email will be sent or entertained separately in this regard.
- 11. It should be noted that incomplete applications those that are without all the supporting documents or do not meet the UGC/DU RULES OR HISTORY DEPARTMENT CRITERIA— will not be accepted and rejected without any explanation. The Department reserves the right to reject the application, even if the candidate has been a part of the previous adhoc panels. No appeal against such rejection will be entertained. Thus, the responsibility of submitting the correct information and all the relevant documents/certificates lies entirely on the candidates.
- 12. The candidate must ensure that the **form has been filled only once**.
- 13. Eligibility Certificates being submitted for OBC and EWS Categories with the form must have been issued during the Financial Year 2022-23 or afterwards as per the Government of India rules.
