



**Notice for Inviting Applications for the Empanelment for the Guest/Ad-hoc Panel of
History
(2026-2027)**

Through this notice, applications are invited on the prescribed proforma for empanelment in the Guest/Adhoc Panel for the posts of Assistant Professor in History in the constituent Colleges of the University of Delhi, SOL and NCWEB for the academic session 2026-2027. Please read the following instructions and Eligibility conditions carefully before applying:

1. Applications are invited from all the candidates who fulfill the minimum eligibility requirements as laid down by the UGC Regulations 2018/University of Delhi/Department Council rules. Candidates must submit their application along with all the necessary self-attested documents mentioned in the form.
2. All the aspirants, including those already having their names in the existing panels, require applying afresh. However, there are two separate forms. (A) Form for the fresh applicants. (B) Form for those who have been already empaneled during 2025-2026. Even the candidates who want to update their academic category are required to fill the form for re-enrollment. **It is mandatory for every candidate to apply again for the purpose of continuation/updation/rectification/correction in the existing data, because all the existing Panels for Ad hoc/guest appointments in history will be automatically lapsed with the issuance of the new Panel to be prepared on the basis of the applications received pursuant to this notice.**
3. **The candidates should fill the prescribed forms by clicking on either of the two below-mentioned Links:**

4. **Note:** The candidates applying for re-empanelment are required to mention their serial number, list number and academic category from the lists of last year (2025-2026). This included AD-HOC PANEL LIST dated 04 June 2025; Additional List I, dated 26 August 2025; and Additional List II dated 24th September 2025. 5. **The deadline for submitting Applications is 07 May 2026, 05:00 PM. After this, the form will be closed.**
6. **Criteria for allotment of categories (as specified by University/Departmental Rules and Regulations) will be as under:**

S.No.	Qualification to be taken into consideration	Category
1.	FIRST DIVISION IN BOTH UG AND PG +Ph.D. in History.	I
2.	FIRST/SECOND DIVISION IN both UG AND PG + Ph.D. in History.	II
3.	FIRST/SECOND DIVISION IN UG AND PG + NET in History.	III
4.	SECOND DIVISION IN UG AND PG + NET in History.	IV
5.	M.A./NET/PhD. (anyone of the three in History)	V

7. ALL applicants must submit either a NET certificate or a NET exemption certificate from their RESPECTIVE Departments. Candidates, who have been awarded a Ph.D. Degree in History in accordance with the University Grants Commission (Minimum Standards and Procedure for award of PhD Degree) Regulations 2009, shall be exempted from the requirement of NET, subject to their production of an appropriate certificate in this respect. The FORM REQUIRED OF RESEARCH SCHOLARS IS APPENDED AS ANNEXURE. If your university provides a different, less comprehensive statement, please submit that form together with ALL the supporting qualifications required by the University of Delhi. This includes a copy of your degree, copies of your two published research papers (cover page/page showing full citation details only) and proof of two presentations in conferences/seminars.
8. Candidates registered for the Ph.D. prior to 11th July, 2009 are governed by the provisions of the then existing ordinances/Bye Laws/Regulations of the Institutions awarding the degree. Such PhD degree holders shall be exempted from the requirement of NET, subject to the production of an appropriate certificate indicating the following:
 - A. That the PhD Degree of the candidate was awarded in the regular mode.
 - B. That the two external examiners did the evaluation of the Ph. D. thesis.
 - C. That an open Ph. D. viva voce examination of the candidate was conducted.
 - D. That the candidate has published two research papers based on his/her Ph.D. work out of which at least one was in a refereed journal. If your certificate does not specifically acknowledge this, then please supply copies of the publications (cover page/page showing full citation details).
 - E. That the candidate had made at least two presentations in conferences/seminars based on his/her Ph.D. work. If the certificate does not specifically acknowledge this, then please supply proof of these presentations.
9. Candidates who have obtained their Ph.D. in the concerned subject from a foreign University that is among the top 500 in the World University Ranking according to QS, THE or the ARWU (see Gazette of India, July 18, 2018, p. 60 for details) have NET exemption.
10. If any condition changes because of the UGC and University of Delhi rules and regulations regarding the qualifications required for empanelment as Ad-hoc/Guest Assistant Professor in the Departments of History of the constituent Colleges of University of Delhi, a notification will be put up and subsequently the Adhoc panel will be revised accordingly. The revised panel, if any, will also be put up on the website. No individual email will be sent or entertained separately in this regard.
11. It should be noted that incomplete applications – those that are without all the supporting documents or do not meet the UGC/DU RULES OR HISTORY DEPARTMENT CRITERIA– will not be accepted and rejected without any explanation. The Department reserves the right to reject the application, even if the candidate has been a part of the previous adhoc panels. No appeal against such rejection will be entertained. Thus, the responsibility of submitting the correct information and all the relevant documents/certificates lies entirely on the candidates.
12. The candidate must ensure that the **form has been filled only once**.
13. Eligibility Certificates being submitted for OBC and EWS Categories with the form must have been issued during the Financial Year 2025-2026 or afterwards (2026-2027) as per the Government of India rules.
14. **How to submit: Candidate need to merge all requisite documents in a single pdf. This PDF should be saved in the name of the candidate. The total size of the merged PDF should not exceed more them 10-20 MB. This merged PDF should be uploaded in the relevant Google form as per paragraph 3 above. Candidates will receive a copy of their filled form on their email after successful submission. Candidates should keep it with them for record purposes to address any future grievance or query.**
15. **Required Documents: Candidate need to upload FOLLOWING SELF-ATTESTED DOCUMENTS strictly in the order of sequence mentioned below after merging these in a single PDF:**

- I. Photograph,
- II. Reserved Category Certificate (Wherever applicable): SC/ST/OBC/EWS/PWD,
- III. Date of Birth Certificate,
- IV. Mark sheets: Graduation, Post-Graduation, M. Phil, Ph.D.,
- V. Degrees: Graduation, Post-Graduation, M. Phil, Ph.D.
- VI. NET/JRF CERTIFICATE IN HISTORY; or NET EXEMPTION CERTIFICATE (together with attachments, if required).
- VII. Publications (first Page only) and Conference /Seminar Presentation Proofs: only for the candidates registered for the Ph.D. prior to 11th July, 2009.
