The election shall be conducted strictly in accordance with the University of Delhi ICC Guidelines. The process is being undertaken to elect **three student representatives** to the Internal Complaints Committee (ICC), ensuring representation of **at least one male student and one female student**, as mandated under Section 4(1)(c) of the University Grants Commission (*Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions*) Regulations, 2015 and Letter Ref. No. PCTO/124/2026/588 dated 30/1/26 issued by the Office of the Proctor, DU.

For the **current academic year**, the seats shall be allocated as follows:

- **Category 1:** PG First Year — **Reserved for a Female student**
- **Category 2:** PG Second Year — **Open seat**
- **Category 3:** Research Scholar — **Reserved for a Male student**

The reservation of seats for female and male students will be based on the principle of rotation every year.

### **Nomination Details (As per University ICC Rules)**

The following eligibility conditions must be fulfilled by candidates seeking election as a student member to the Internal Complaints Committee (ICC):

1. The candidate must be a regular student enrolled in a degree programme of the University and must be a *bonafide* student of the Department of History.
2. The candidate must have secured a minimum of 75% attendance in the previous year/semester, as applicable.
3. The candidate should have NO backlog papers.
4. The candidate must have obtained at least 55% aggregate marks in the most recent final examination, as applicable to their category:
  - a) For PG First Year students, the aggregate marks shall be calculated on the basis of the final examination of the Undergraduate (UG) programme.
  - b) For PG Second Year students, the aggregate marks shall be based on the final results of the PG First Year (all semesters completed so far).
  - c) For Research Scholars (M.Phil./Ph.D.), the aggregate marks shall be determined on the basis of the final examination of the Postgraduate (PG) programme.
5. The candidate should not have been subjected to any disciplinary action in the past, must have no criminal record and must be willing to perform responsibilities in accordance with ICC norms.
6. The candidate must not have contested the Tier-II ICC election earlier.

The terms and conditions relating to **eligibility, conduct of election, nomination, scrutiny, withdrawal, shortlisting, polling, declaration of results, tenure of representation**, and all other matters concerning the **ICC Election 2026** shall be strictly governed by the Guidelines issued by the **Office of the Proctor** and the **Election Committee, ICC 2026, Department of History, University of Delhi**.

Candidates shall submit all relevant documents in support of their eligibility, including **self-attested copies of their University Identity Card** and supporting **mark sheets according to their respective categories**, along with the duly completed **Nomination Form (Annexure-I)** and a **Self-Declaration/Affidavit** executed on Non-Judicial Stamp Paper (**Annexure-II**).

Each nomination must be proposed and seconded by registered students respectively belonging to the concerned category. In the event of any disagreement, discrepancy or ambiguity, the final decision shall rest with the Election Committee ICC, 2026 Department of History DU.
